

富融銀行開戶推廣「PUBG MOBILE: 絕地求生 M」優惠條款與細則 ("條款與細則")

一般條款與細則

- 1. 推廣期由 2021 年 12 月 24 日起至 2022 年 5 月 31 日止包括首尾兩日,下稱「推廣期」。
- 2. 以下推廣優惠(「優惠」)只適用於 2021 年 12 月 24 日至 2022 年 5 月 31 日(包括首尾兩日,下稱「開戶期」)首次成功開立富融銀行(「富融銀行」,下稱「本行」)戶口之特選客戶(「特選客戶」),而該戶口需維持正常狀態。
- 3. 是次為一次性優惠, 是次優惠不能轉贈他人或兌換成其他產品。
- 4. 本行保留對是次優惠的任何調整,收回或取消的權利,亦會不時對此條款與細則作出修訂而毋須事先通知或原因。在推廣期間,特選客戶在申請本行戶口時需遵守這份條款與細則。

- d. 本行通過短信形式分別將 1500 UC 及一套風速少女限時 10 天的兌換皮膚的兌換碼 發送至特選客戶的登記手提電話號碼後,特選客戶須負責保管該兌換碼獎賞。如

<u>Fusion Bank New Account Opening "PlayerUnknown's Battlegrounds Mobile" Promotion Offer</u> Terms and Conditions ("T&Cs")

General Terms & Conditions

- 1. The promotion period is valid from 24 December 2021 to 31 May 2022 (both dates inclusive, hereinafter called the "Promotion Period").
- 2. The promotion ("Offer") is only applicable to selected customers (" Selected Customer(s)") who successfully opens a valid bank account with Fusion Bank Limited ("Fusion Bank" or the "Bank") during 24 Dec 2021 to 31 Mar 2022 (both dates inclusive, hereinafter called the "Account Opening Period") for the first time and such bank account shall remain in normal status.
- 3. The Offer shall not be renewable. This Offer cannot be transferred to others or converted to other products.
- 4. The Bank reserves the right to adjust, withdraw or cancel the Offer, and to amend or revise any of these T&Cs from time to time without prior notice and without assigning any reasons whatsoever. The Selected Customers will be subject to these T&Cs in force at the time of applying to the Bank for account opening during the Promotion Period.
- 5. In case of any ambiguity, doubts or disputes arising out of or under any of these T&Cs or communications, the decision of the Bank is final and conclusive in all circumstances without assigning any reasons whatsoever.
- 6. These T&Cs are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region ("Hong Kong"). The parties submit to the jurisdiction of the courts of Hong Kong.
- 7. The Offer shall be subject to the Bank's applicable terms and conditions, including the General Terms and Conditions and other related terms and conditions issued by the Bank, save as otherwise amended, revised or supplemented herein.
- 8. No person other than the Selected Customers and the Bank (including its successors and assigns) will have any rights under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provision of these T&Cs.
- 9. In the event of any discrepancies or inconsistencies between the English and Chinese versions of these T&Cs, the English version shall prevail.

PlayerUnknown's Battlegrounds Mobile ("PUBGM") Promotion

a. This promotional offer is only applicable to Selected Customers who successfully opened an account with the Bank for the first time during the promotional period and such bank account shall remain in normal status. If customer has previously closed their Fusion Bank account in the past 1 year, the customer is no longer eligible to participate in this promotion even if customer successfully opens a new Fusion Bank with the exclusive invitation code.



- b. During the Promotion Period, Selected Customer needs to download the Fusion Bank App and enter the exclusive invitation code "PUBGM" of this promotion when opening an account. If Selected Customer successfully opens a Fusion Bank account for the first time using this exclusive invitation code, the Bank will send a SMS notification for reward redemption within 7 working days to the registered mobile number of the Selected Customer. The Fusion Bank account of the Selected Customer should remain valid and maintain in normal status at the time of sending SMS notification for reward redemption by the Bank.
- c. The SMS notification for reward redemption includes a redemption code for 1500 UC reward and special skin 10-days trial, customer can visit https://www.midasbuy.com/midasbuy/hk/redeem/pubgm and enter redemption code to redeem 1500 UC reward; visit https://www.pubgmobile.com/act/a20180515iggamepc/ and enter redemption code to redeem special skin 10-days trial. If Selected Customer has not opened a PUBGM user account yet, please download the PUBGM App from App Store or Google Play in advance to become a PUBGM user.
- d. After the Bank sends the redemption code of the 1500 UC and special skin 10-days trial reward via SMS notification separately to the Selected Customer, the Selected Customer shall be responsible for keeping the redemption code properly. In the event of loss or misappropriation, the Bank shall not bear any responsibility for this.
- e. The 1500 UC redemption code provided by the Bank will be expired on 20 December 2022. The special skin 10-days trial redemption code provided by the Bank will be expired on 30 June 2022. The redemption code will be voided automatically if it is not used by the expiry date and no reissuance of the redemption code will be arranged. The rewards are limited and are only available while stocks last.

The customers who successfully open an account via the exclusive invitation code "PUBGM" on or before 28 March 2022 and have received the 1,500 UC reward redemption code, the Bank will send special skin 10-days trial reward redemption to the customers' registered mobile number on or before 31 May 2022.
- g. Fusion Bank is not the supplier of the PUBGM App. Therefore the Bank will not have or accept any liability, obligation or responsibility whatsoever for the use of PUBGM rewards after finished the redemption (including without limitation consequential loss, destruction or damage).
